The Central Noble Community School Corporation Board of Education met in regular session on Tuesday, May 21st at the Central Noble Administrative Offices.

The meeting continued with the following Administrator Comments:

- Mr. Gaff noted the included draft of the Coop Joint Services Agreement will be up for approval at the June meeting
- Mr. Knipper noted that testing is complete. They celebrated Grandparents day with a record number in attendance.
- Mr. Morgan touched on PBL projects: (1) Mrs. Wood's class sold dog treats they made to make a donation to the Humane Society and (2) Mr. Stump's class built a smoker and smoked pulled pork. With the project, students were able to use reading, math and other skills. He also noted that they are working through the stages to begin a Nature Based preschool next year in cooperation with Cole YMCA and Merry Lea. They have found a therapy dog and training will be done in Tennessee at a highly discounted rate. He also noted that NWEA scores showed that 88% are at or above level. He also made note that they are currently at 90 enrolled Kindergarteners.
- Office Worman noted that he attended School Safety Specialist training and plans to perform a full reunification in the fall with notes and advice from the training. He will also run summer weights on Monday, Wednesday and Thursday and also talked about CN Streaks movement to keep kids and adults alike moving this summer.
- Mr. Moe gave an athletics update and also noted that all testing is complete.
